- Actively scan and watch your assigned area during lifeguard shifts at the pool.
- Manage swimmer behavior by enforcing clear rules and use a variety of positive behavior reinforcement strategies.
- Adhere to all Beachmont Christian Camp policies, procedures, emergency action plans, and COMAR requirements for a summer day camp.
- Faithfully and joyfully perform all chores, opening tasks, closing tasks, and any other work-related duties as assigned.
- Complete all required paperwork in a professional timely manner.
- Be a positive member of a team who seeks to serve others and resolve any conflicts in a biblical manner.
- Model Godly, professional, and appropriate behavior to all guests and staff.
- Follow the assigned schedule and find coverage when unable to work.
- Attend all assigned meetings and work shifts in a punctual manner.

# **Position Requirements**

- Must be at least 15 years old.
- Must be lifeguard certified by a recognized organization such as Red Cross, YMCA, etc.
- Must be present for all required training unless an exemption is given by the Pool Manager.
- A passion for working with children.
- Ability to manage the needs of multiple people, simultaneously.
- Ability to adhere to safety protocols, including all policies and procedures.
- Each staff member must complete a background check in order to be hired.
